2 the state Constitution, the Washington State Redistricting Commission,  
3 on January 1, 2012, approved and submitted to the legislature a plan  
4 for the redistricting of state legislative and congressional districts,  
5 as represented by "The Resolution of Redistricting Congressional and  
6 Legislative Districts" (Z-0974.3/12); and

7           WHEREAS, Pursuant to RCW 44.05.100, the legislature desires to  
8 amend the boundaries of certain congressional districts as follows:

10 672,449 to 672,444 people; and
