1. CALL TO ORDER

The meeting was called to order at 6:30 p.m. with Lura Powell presiding as Chair.

2. SPECIAL COMMISSION MEETING FOR RULES HEARING, JULY 6, 2011 3:30 P.M. – 4:30 P.M., DESIGNATION OF HEARINGS OFFICER
